Do you know someone who is Hall of Fame worthy? The DPCBA started honoring their members with this highest of awards in 1965. The PWBA began their Hall of Fame in 1990. Today the HVUSBC carries on the tradition of honoring local bowlers for outstanding achievements on the lanes and extraordinary service in supporting Hudson Valley bowling.

What Makes Someone a Hall of Fame Candidate? We have two categories:

Candidates for **Superior Performance** represent the quintessential bowler. This is someone who has been an adult member of the HVUSBC (DPCBA / PWBA included) for at least 20 years. This is a bowler who not only holds a high average and multiple honor scores, but is also a leader. They strive not only to be a great bowler, but to make others great as well. They share advice and knowledge with teammates and opponents alike. They are the bowlers who have that intangible ability to come through in tough situations. They compete, sometime ferociously, on the lanes, love competition, and always exhibit good sportsmanship. They are the people you look forward to bowling with or against.

Eligibility for *Superior Performance* Consideration:

1. Candidates should be, or have been, a bowler in good standing in leagues sanctioned by the HVUSBC, DPCBA, or PWBA for a minimum of 20 years while earning achievements.
2. Candidates must have competed in the HVUSBC Annual Championship or Scratch Tournament for at least 10 years.

Nominees for **Meritorious Service** should have contributed significantly to the support of local bowling through their volunteer work. They are the people that keep the HVUSBC running through their love of bowling. Their ideas and devotion go above and beyond the average volunteer. They sacrifice their free time to promote and grow the sport of bowling in the Hudson Valley. They coach our youth bowlers, and run our local tournaments. These candidates may be bowlers, youth volunteers, coaches, proprietors, league officers, association volunteers, or anyone who has devoted themselves to the sport of bowling within the local community.

Eligibility for *Meritorious Service* Consideration:

1. Candidates should be, or have been, involved in the support of local bowling for a minimum of 20 years.
2. Consideration shall be given to volunteer work supporting the local association and its leagues, as well as director and/or officer roles, and coaching.

Please help us find the people that deserve to be recognized.

Careful consideration should be given before submitting a candidate's name. Nomination should be in written form using this Application and must be submitted to the HVUSBC Association Manager no later than December 31st for induction the following spring. The nomination form must be signed by the submitter, and as much information and documentation as can be obtained should be included. You can involve the individual you would like to nominate if you want. It is sometimes hard to find records of achievements, and the Hall of Fame Committee will try to fill in missing information whenever possible. All applications will be kept on file for 3 years and may be updated annually. After 3 years a new application must be submitted.
